Highlights

1993 Council of UC Retiree Associations (CUCRA) formed to pursue retiree representation on the Office of the President Advisory Board for benefits and establish relationships with retirement groups such as the Council of UC Emeriti Associations

1993 Academic Senate Office reinstated .25FTE secretarial assistance to **UCDEA** with \$2,000 for office expenses

1994 (winter) **UCDRA** life membership established at \$50

1996 (fall) **UCDRA** on the web

- The *UCD Retiree* and new UCDRA brochure on the web through the campus HR webpage

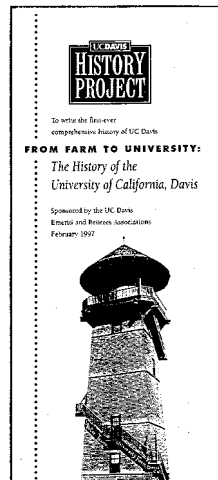
1996 UC Davis History Committee split from Historical and Video Records Committee

- UC Davis History Project launched, chaired by Dick Gable, another joint venture between **UCDRA** and **UCDEA**

1997 (fall) History Committee selected Ann Foley Scheuring to write history of UC Davis

- Fundraising conducted by both **UCDEA** and **UCDRA**

1997 Life membership for **UCDEA** established at \$200, with 36 lifetime members



Highlights

- 1999** (October) **UCDRA** established UC Davis Staff Scholarship for a staff person “to use to further his/her educational goals in the coming year”
- awarded at spring Thank Goodness for Staff (TGFS) event
 - Mical K. Shilts, Dept. of Nutrition; first recipient

1999–2000 Emmy Werner named as the first UC Davis recipient of the Constantine Panunzio Distinguished Emeriti Award

Winter **2001** first **UCDEA** website launched by John Owens

Spring **2002** The **UCDRA** and **UCDEA** advocated for a campus health care ombudsman; Guerren Solbach became the first Health Care Facilitator for UC Davis

November **2002** Initial proposal for a UC Davis Retiree Center developed and submitted to campus administration by **UCDEA** and **UCDRA**

July 1, **2006** UC Davis Retiree Center established as a result of the **UCDEA** and **UCDRA** committee

2006–2007 Dick Walters; first recipient of the Edward A Dickson Emeritus/a Professorship

2008 Wayne Thiebaud; first recipient of the UC Davis Distinguished Emeritus/a Award

2008–2009 UC Davis Extension offers first year free OLLI membership to **UCDRA** and **UCDEA** members

April **2009** Lorena Herrig; first **UCDRA** Picnic Day Parade Honoree



Fall **2009** redesigned newsletter, *Campus Connections* replaces *Emeriti-Times* and *The UCD Retiree* as a joint publication between **UCDRA** and **UCDEA**, with Nora McGuinness as **UCDEA** editor and Barbara Anderson as **UCDRA** editor

Spring **2010** UC Davis Centennial DVD Project completed; 23 DVDs with excerpts from over 150 interviews representing faculty and administrators from colleges, schools and other campus units, compiled by Verne Mendel

March **2012** — President Mark Yudof formally recognizes all UC retiree and emeriti associations as “affiliated organizations”

Sept **2013** — Noon Talks renamed BrainFood Talks, still held second Thursday of the month at the Walter A. Buehler Alumni Center, sponsored jointly by **UCDEA/UCDRA**

Advocacy Pays Off

Successes include...

Representation on system-wide task forces and councils led to:

- Guaranteed maintenance of a base for retiree pensions, including COLA adjustments
- Elimination of the nine-month limit for withdrawal by spouse beneficiary of 403(b) funds following annuitant's death
- Campus Health Care Facilitator Program established and maintained
- Affordable Medicare and medi-gap health plans

Working with campus leaders led to:

- Free parking for retired staff and emeriti
- Clarification of library card policies for emeriti and retired staff
- Aggie ID cards for retired staff and emeriti
- Free OLLI membership
- Representation on Faculty Welfare and Emeriti Welfare Committees
- A great home for the Retiree Center in the Walter A. Buehler Alumni Center



Recollections from past presidents

UCDEA President 1994–1996



Verne Mendel

I recall two matters that arose during that time frame. First, the campus administration proposed—for the first time, I believe—an end to free parking privileges for retirees. Fortunately, our appeal for retention of the privilege was successful.

The second was beginning talks about the need for a retiree center to serve both retired staff and emeriti.

Together with UCDEA, I promoted the UCD History Project and appointed two representatives (Robert Ball and Deanna Falge Pritchard) to represent UCDRA, who along with other UCDRA volunteers undertook fund raising with UCDEA. This effort culminated in the publication of “Abundant Harvest, the history of UC Davis” in time for the Centennial celebration.

UCDRA President 1997-1998

Deanna Falge Pritchard

Good succession planning is vital to the leadership of the association. I advanced to the presidency without the advantage of serving as vice president upon the resignation of Bob Ball who underwent a heart transplant. Because of that, a second vice president position was established. I also drafted the proposal for the new retirees reception.

Since 1996-97 to the present, I have served on the UCDRA Executive Board, the Retiree Center Advisory Committee, or CUCRA in various capacities and have seen the increase in activities, outreach and dedication of the organizations to the university.

The early years were difficult finding a slate of officers and board of directors, but times have changed into a viable working unit with a Retiree Center.

UCDRA President 2001–2002

Howard Frank

I initiated contact to retiree centers on other UC campuses to determine the viability of establishing a retiree center at UC Davis to serve UC Davis emeriti and retired staff. I met with UCDEA President Ed Costantini and selected members from both associations to review findings of the survey, as described in Charles Hess' history, "The History of the UC Davis Retiree Center, from Concept to Reality."



UCDEA President 2002–2004

Campus administration proposed—for the first time, I believe—an end to free parking privileges for retirees. Fortunately, our appeal for retention of the privilege was successful.

The proposal for what became the UCD Retiree Center was developed and submitted in November 2002. In due course, of course, the proposal was approved by Virginia Hinshaw (campus Provost).

The Center became a “game-changer” for our two organizations and their members.

I brought the director of the Berkeley center to give an inspiring talk for the provost, a major step on the way to approval of a retiree center for Davis.

A highlight for me was the development of a proposal to establish a UC Davis retirement center involving colleagues from the UC DRA, UCDEA and the administration and implementing that proposal as the first chair of the Retiree Center Advisory Committee. The development and implementation of the Retiree Center proposal facilitated a closer working relationship between the UC DRA and UCDEA,

raised the awareness of the contributions that retirees continue to make to the university, and provided the opportunity to advocate for the rights and privileges of retirees.

UCDRA President 2005–2006

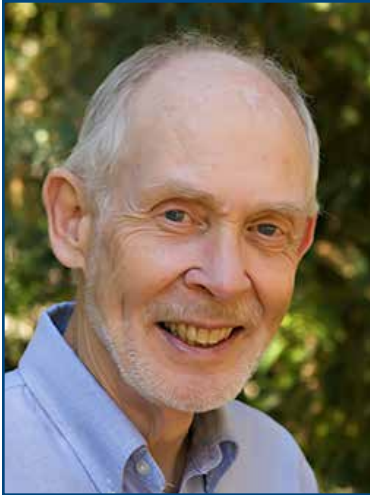
Barbara Nichols

During my term, two accomplishments stand out. One was working with other UCDRA folks and UCDEA representatives to move forward the development of the Retiree Center, including its name, structure and first staff member. UCDRA President 2006-2008

The most significant event as president was the establishment of the UC Davis Retiree Center. The start-up of the Center operations brought with it the need for Center and association budget decisions, improvement of our membership database, close work with the Center staff and coordination with the UCDEA. The Executive Board's preference for continuity of leadership during this time was the reason for my serving two years as president instead of the traditional one-year term of office.

My most vivid recollection is of yet another heated annual battle over retiree parking. This time the parking Czar was proposing implementing annual charges. We fought the battle hard and this time in the open. I remember writing a rather sharp letter to the campus community. This appeared to precipitate action with the result that permits were to be continued with an every-other year review. A permanent budget allocation was added to the Retiree Center budget to support parking. Things seem to have gone smoothly since.

Additionally, I participated in hiring Sue as Center director which has been, I believe, a good thing for all of us.
