You should have received a temporary pink retirement card when you retired, which can be exchanged for a permanent ID card at Dutton Hall on the UC Davis campus. Greetings from Chancellor Katehi

August 17, 2009

Dear UC Davis Community Members,

Today I officially join UC Davis' family as chancellor, honored beyond measure and eager to get to work on this university's behalf.

Spyros and I flew to Sacramento yesterday morning, waiting for the movers to arrive today, hopefully with everything intact. It will take us a couple of days before we can find our things!

Our first day on campus started yesterday afternoon with a welcome to the law school's alumni board, followed by a barbecue for first-year law students. Both were very exciting events. I particularly enjoyed meeting with the students because they and I have many things in common—we are both very new to the campus and eager and anxious about the days ahead. The day ended with a red-eye trip to Washington, D.C., so I can participate in an education policy dinner discussion tonight hosted by Secretary of State Hillary Rodham Clinton. While in Washington today, I will also meet with Department of Energy officials, advocating consideration of UC Davis as the home of a DOE energy innovation hub. DOE couldn't ask for a better partner in this area,

nor could the State Department find a surer bet in its priority area of science diplomacy. And I will take advantage of every opportunity to advance UC Davis' interests.

Most immediately, in the days ahead, we must stabilize our state budget. UC President Mark Yudof has called for shared sacrifice in the short term, and the regents have launched a commission on the long-term future of UC. They recognize that furloughs, salary reductions and steadily increasing student fees are simply not sustainable, and that ingenuity and determination are required if we are to ensure the continued long-term quality of this university. I share that view, knowing that we have difficult choices ahead to close this year's budget gap, to resolve uncertainty, and to identify ways that will ensure financial stability and preserve our capacity to lead. We will do that together, openly, honestly, and with care because these choices have deeply personal consequences. And, at the same time, we will focus intensely on identifying and responding to new opportunities that have the potential to help us financially but also bring the academic excellence and vitality our institution strives for.

My first 100 days will continue an intense "listening tour" begun when my appointment was announced last May. This first week I am meeting with faculty, student, staff and legislative leaders, key funding partners, and our provost, deans and vice chancellors. I am planning visits to all of the colleges and schools and town hall meetings, and I'll continue the tradition of brownbag chats at both the Davis and Sacramento campuses. As well, I plan to make good use of my Web page (<http://chancellor.ucdavis.edu>) for sharing information and for seeking your comments.

I look forward to working with you and learning from you as, together, we ensure a sustainable and transformative future for UC Davis.

Maintaining the Emeriti Association's paper trail

I have noted some missing records, and I would like to fill in the gaps. This brings me to my request to all current and former Emeriti Association officers. Please check

your closets, shelves and filing cabinets, or miscellaneous boxes in your garage for any older records of Emeriti Association activities, reports, surveys and copies of *EmeriTimes*, and bring them to the Retiree Center in Everson Hall. While I don't have all the gaps identified, I know we are missing all issues of *EmeriTimes* for vol. 2 Fall 1991–Spring 1992 and vol. 13 Fall 2002–Spring 2003. There is only one issue for vol. 1, no. 1, November 1990, in our files. Ideally, archivists like to have two copies of each document, so bring any issues you have. Thank you for helping me ensure that our archives are as complete a record as possible of the association's business and activities.

President Yudof's call to action on state funding for UC

Editor's note: Although the Legislature began its fall recess before Campus Connections went to press, we encourage you, as annuitants, to express your opinions to your elected representatives and to the Governor on this ongoing, important matter.

Dear Friends of UC:

I'm writing to urge you to be part of a letter-writing campaign on behalf of UC and public higher education in the remaining few weeks before the Legislature's fall recess.

The University of California is a vital engine of opportunity, possibility, and leadership for California. For 140 years, the university has worked to develop the human capital of California, energize its economy, and advance its health and wellbeing. UC education and innovation have helped power California's rise to its position of global economic and cultural leadership.

That can continue to be the case—but we need the state's support. As you know, the state budget process for 2009–10 ended recently with a budget that leaves UC with 20 percent less state funding than it had at the beginning of last year. Faculty and staff pay reductions, student fee increases, and program cuts at campuses and the Office of the President all

are being implemented to cope with this immediate budget crunch.

But this short-term response is not sustainable. Already, our campuses are seeing signs of “brain drain” as faculty recruitment is slashed dramatically, programs are pared back or put on hold, and competing institutions seek to lure our world-class faculty and staff away.

As we look to the 2010–11 budget, we face even more challenges: Federal stimulus funds probably won't be continuing. Emergency measures we took this year—such as the employee pay reduction—can't be continued without doing major harm to UC's quality. Health benefit costs are continuing to rise. And a dramatic turnaround in the state revenue picture simply does not appear likely—already, there are warnings of a \$7 billion–\$8 billion budget deficit in 2010–11.

Academic quality, student access, and student affordability are all at risk. More than that, California's innovation economy and the educated workforce that sustains it will wither if the slide in state support for public higher education is not halted and reversed.

Now is the time to let the Governor and Legislature know that you care. about investing in California's future through higher education.

We're not just holding out a tin cup. We're making huge efforts across the UC system to save money, achieve efficiencies, re-examine our financial models, and be creative about how to operate in the new fiscal reality. But state support is still critical to the core instructional program at UC, and if it doesn't rebound, the impacts to California will be more shocking than I think most people realize today.

I encourage you to take this opportunity to email the governor, the legislative leadership, and your local members of the State Assembly and State Senate and tell them:

- how UC has made a difference in your life and in the life of California.
- what diminished investment in opportunity and innovation will mean to you.
- and ask that public higher education be a priority in next year's state budget.

Please join us in this movement—one that will continue throughout the coming year—to ensure that California's future is one of hope and promise.

New parking privileges for UC retirees

The Retiree Center has arranged with Transportation and Parking Services (TAPS) to offer complimentary RT parking permits to retirees from other UC campuses or the Office of the President who join either the UCDEA or the UCDDRA.

We don't anticipate that this will affect a large number of people, but those who live in the area, and who retired from a campus other than UC Davis, will benefit from parking at no charge while they visit the Retiree Center, use the library or the ARC, or attend events at the university.

Association members who retired from other campuses should contact the Retiree Center, and Center staff will notify TAPS of the member's eligibility for a parking permit. If you are a UC Davis retiree and know of someone who might be eligible, please pass the word along.

Maintaining a UC Davis e-mail address

Having a *ucdavis.edu* e-mail address is a benefit to retirees. For example, AT&T offers a discount on cell phone service to affiliates of UC Davis, and requires a UC Davis e-mail address as proof of affiliation.

When they retire, emeriti can request, through their departments, to keep their e-mail account as a lifetime benefit. Staff have the option of applying for a complimentary service that will forward their *mailid@ucdavis.edu* to an external e-mail address of their choice (e.g., *user@yahoo.com*).

Until recently, this service has been available only to those who retired after 2005, but the Retiree Center has worked with campus Information and Educational Technology (IET) to offer this benefit retroactively to pre-2005 retirees.

Recent retirees must submit forwarding requests within 90 days of retiring to: <http://emailforwarding.ucdavis.edu>.

Retirees who left campus prior to 2005 may contact the Retiree Center to request the reinstatement of their *ucdavis.edu* address and register for the forwarding service. Retirees may not be able to retain their original address if it has already been assigned to another employee.

Edward A. Dickson Emeriti Professorship

The Edward A. Dickson Emeriti Professorship, which was held in 2008–09 by Manny Epstein, will be open again in 2009–10. The call for nominations is going out a little later than normal this year, as funding had to be confirmed. The Awards and Recognition Committee invites emeriti or emeritae to apply by submitting a proposal stating how they would use the stipend attached to the professorship, projected to be \$10,000 or less, to support teaching, research and/or public service projects for the benefit of the Davis campus.

Applications are due by November 13 to Ed Rhode, chair of the committee. Applicants for this professorship should submit a concise proposal to the committee with a budget and justification for categories such as salaries, supplies and travel. The Awards Committee will evaluate the proposals and submit those deemed meritorious to the Vice Provost for Academic Personnel for approval. The awardee will hold the Professorship through August 31, 2010, and must submit a report on the project at the end of the appointment. Questions should be directed to Ed Rhode, earhode@ucdavis.edu.

Call for UC Davis Distinguished Emeritus/a Award

It's time to nominate a colleague for the UC Davis Distinguished Emeritus/a Award which honors outstanding scholarly work or service performed since retirement. Service may be in professional, university, Academic Senate, emeriti, departmental or editorial posts or committees.

Initial nominations should be addressed to the president of the Emeriti Association, c/o UC Davis Retiree Center (retireecenter@ucdavis.edu). Please include a candidate's curriculum vitae and a nomination letter. Nominations must be received by November 13.

Nominations will be passed on to the Awards and Recognition Committee. The committee will select one or more finalists for whom a full dossier containing support letters from leaders in the nominee's field will be developed. The award will be announced in spring 2010, and the nominee will be honored at a campus event and given a suitable memento or cash award.


Joint Program Committee announces 2009–2010 schedule
