Dear Colleagues:

the Centennial website. Five more (total 8) will be ready this week. An additional five (total 13) require only to have the narrative added, which will take about another week. Three more (total 16) are completed but, after proofing, will require minor editing. Thus, completion of 16 is within reach by the end of the month. Finishing these 16 DVDs leaves only five more to complete the project. Two of the final five have been produced but require significant editing. The last three need to be constructed from the component parts which are already available.

The Video Records Committee still has its work cut out for it. Verne is working hard to finish the Centennial project by the end of May, and we are all trying to help him. He remains dedicated and committed, even given his personal grief, and we all owe him a great deal. ### **Presidential Task Force on Post-Employment Benefits**

The Board of Regents, at its February 6, 2009 meeting, approved the recommendation to restart contributions to the UC Retirement Plan. As part of that action, a Presidential Task Force on Post-Employment Benefits was authorized to develop a comprehensive, long-term approach to UC obligations for all post-retirement benefits. This Task Force will make recommendations to the President on the long-term funding, benefits policy, and alternatives for retirement benefits for UC faculty and staff. The Task Force is to take into consideration issues of market competitiveness, work force development, affordability, and sustainability. The goal is to include the Task Force recommendations in the budget and planning cycles for Fiscal Year 2011/12.

The Task Force will consist of and consult with representatives from a cross-section of UC stakeholders, including Academic Senate members; campus, medical center and laboratory leadership; and staff representatives. The Task Force will be organized into two teams: a Steering Committee and a Work Group. The Work Group will be under the direction of the Steering Committee and will both provide appropriate analysis of the relevant data and assess alternatives. The Steering Committee will forward its final recommendations to President Yudof, based on the options evaluated by the Work Group. Chancellor Larry Vanderhoef will be a member of the Steering Committee. I have been asked by Executive Vice President Katherine N. Lapp to serve on the Work Group in my role as chair of CUCEA. Marian Glade, chair of the Council of UC Retirees Association (CUCRA), will also serve on the Work Group. John Meyer, UC Davis Vice Chancellor for Resource Management, and Jim Chalfant, faculty member in our department of Agricultural and Resource Economics and past chair of the UC Faculty Welfare Committee, will both serve on the Work Group. The members of the Steering Committee and the Work Group will be divided into three teams to address the following topics: retiree health benefits, pension plan, and finance & funding. The Steering Committee met on March 9 and the Work Group had its first meeting in early April.

The challenges facing the Task Force have been increased by the fact that the budget which the legislature passed and the governor signed did not include the \$20 million state contribution to the UCRS that had been anticipated when The Regents approved the restart of employee contributions. Another challenge is that as of December 31, 2008, the UC Retirement Plan has experienced a one-year decline of 28.21%. The current market is not improving that situation,

as anyone with equities is experiencing. A final challenge is posed by a change in accounting standards. The Retiree Health Benefits Program cost \$225 million in 2008 and is projected to grow to \$416 million in 2013 when expressed on a pay-as-you-go cash basis. Under the new accounting standards established by the Government Accounting Standards Board (GASB) in 2004, the University has to express the projected cost of retiree health benefits of active employees in addition to the current health benefit costs for retirees. Using this accounting standard, the Unfunded Retiree Health Benefits Program Liability grows from \$13.3 billion in 2008 to \$18.9 billion in 2013. Trying to find a way to deal with declining resources and increased costs will not be an easy task.

### **Update on Outsourcing**

As you know, since last fall we have been anticipating a decision about outsourcing the Retirement Division of Human Relations and Benefits. Most emeriti did not support outsourcing. President Yudof has chosen NOT to pursue outsourcing at this time, and instead, has directed EVP Lapp to begin a process to structure the Retirement Administration unit as an Office of the President Service Center distinct from the Human Resources Department. More details will be provided in the near future.
